NOTICE

With effect from the academic session 2022-23, the following scholarship schemes areavailable for the aspirants seeking admissions in various programmes of study at the undergraduate and postgraduate levels at the University.

SNU Merit Scholarship:

- 1.1 A student securing more than or equal to 95% marks in the qualifying examination for diploma/undergraduate programs of study (i.e. Class 10 forDiploma in Engineering, Class 12 for undergraduate programs) and more than 75% marks in the qualifying examination for postgraduate programs of study (i.e. Graduation examination for postgraduate programs) shall be eligible to get 100% scholarship which is equivalent to 100% of the Tuition Fees payable by the student.
- 1.2 For a student, secured 90% and above but below 95% in the qualifying examination for diploma/undergraduate programs of study and secured 70% and above but below 75% in the qualifying examination for postgraduate programs of study, then the student shall be eligible to get remission of 75% tuition fees payable by the student.
- 1.3 For a student, secured 85% and above but below 90% in the qualifying examination for diploma/undergraduate programs of study and secured 65% and above but below 70% in the qualifying examination for postgraduate programs of study, then the student shall be eligible to get remission of 50% tuition fees payable by the student.
- 1.4 For a student, secured 80% and above but below 85 % in the qualifying examination for diploma/undergraduate programs of study then the student shall be eligible to get remission of 25% tuition fees payable by the student.
- 1.5 The scholarship shall remain valid over the semesters (for semester schemeprograms of study) and years (for annual scheme programs of study), <u>unless the performance of the student falls below the desired level or a penal action has been taken against the student for any reason_and as would be decided by the respective Head of the Department and intimated to the office of Registrar and the Vice Chancellor.</u>
- 1.6 Once, as student has been granted any one of the above scholarship schemes and has availed such, he or she shall not be allowed to apply for any other scholarship scheme, including those given by Government Departments, Corporates etc.
- 1.7 All such scholarship shall necessarily need to be approved by the Vice Chancellor through the Central Admission Coordinator (CAC), beforebeing offered.
- 1.8 Before availing a scholarship scheme a student has to give a declaration (asprovided in Annexure-1) countersigned by parent/guardian to the effect that the awardee of scholarship, is aware of the point 1.3 above and that after successfully graduating from the University and after being successfully placed in the career, he/she shall necessarily financially support a needy or economically child to pursue education, as a part of social responsibility; and that he/she after supporting someone needy/economically challenged child shall let know the University the details of this, so that the Universitymay put the fact on record.



SNU Talent Scholarship:

- 2.1 Any talent in the field of sports, performing arts (e.g. singing, dancing, drama etc.), visual arts (e.g. painting, sculpture etc.), who have represented State or Nation in a National or International meet/ performance and who meets the eligibility criteria for admission to any undergraduate/postgraduate program of study, may be offered 50% scholarship which is equivalent to 50% of the Tuition Fee payable by the student. Depending upon the applicants merit the scholarship amount may be increased with due approval of the Vice Chancellor.
- 2.2 The scholarship shall remain valid over the semesters (for semester scheme programs of study) and years (for annual scheme programs of study), unless the performance of the student falls below the desired level or a penal action has been taken against the student for any reason, as would be decided by the respective Head of the Department and intimated to the office of Registrar and the Vice Chancellor.
- 2.3 Once, as student has been granted any of the above scholarship scheme and has availed such, he or she shall not be allowed to apply for any other scholarship scheme, including those given by Government Departments, Corporates etc.
- 2.4 All such scholarship shall necessarily need to be approved by the Vice Chancellor through the Central Admission Coordinator (CAC), before being offered.
- 2.5 Before availing a scholarship scheme a student has to give a declaration(as provided in Annexure-1) countersigned by parent/guardian to the effect that the awardee of scholarship, is aware of the point 1.3 above and that after successfully graduating from the University and after being successfully placed in the career, he/she shall necessarily financially support a needy or economically child to pursue education, as a part of social responsibility; and that he/she after supporting someone needy/economically challenged child shall let know the University the details of this, so that the University may put the fact on record.

Chancellor Merit cum Means Scholarship

- 3.1 This Scholarship is directly granted by the Hon'ble Chancellor, Sister Nivedita University.
- 3.2 Under this scholarship scheme a remission of 50 % to 100 % of total fees is waived for the needy students.
- 4. Cancellation of scholarship: If at any stage it is found that the candidate has suppressed facts and/or have submitted any forged documents, the scholarship shall stand withdrawn immediately.
- 5. As per Section 5(2) of Sister Nivedita University Act, 2017; the University shall offer free-ship in tuition fees to at least 5% of its total strength, to the students belonging to poor and economically backward classes.
