Syllabus Draft Masters in Political Leadership and Governance MBA

Aim of the Course

The course focuses on creating the next generation of corporate leaders who can analyse and understand the complexities of contemporary industries and markets. Students will be encouraged to understand state politics and their relationship with industry and entrepreneurship.

Outline of the proposed Course Structure:

The course would consist of 4 semesters. The first two semesters would involve lectures classroom teaching and assessments on selected modules. The 3rd semester would be reserved for fieldwork and training of students in various techniques of fieldwork and methods of data collection. Students will receive training in the usage of various data collection tools and methods such as surveys, interviews, sampling, and ethnography covering both quantitative and qualitative methodologies. The final semester would require the submission of a dissertation on a topic of choice. The possibility of student internships with organizations and institutions working to bring about positive social transformations can also be explored in this period to give students a practical test scenario where they can employ the skills learnt during the duration of the programme. The total number of credits for the programme would be around 120 at par with other Master's programmes in Indian universities. Students would also be given the option to choose a module according to their preferences in the first two semesters during their coursework.

Structure – 4-semester courses

Semesters One and Two: Taught courses classroom teaching [Exit Option might be offered at the end of Sem 2] Semester 3: Involves students in the colloquia and **Semester 4**: would require the students to write a dissertation on their chosen field among the given colloquia.

The credit distribution in the 3rd and 4th semesters will receive the same weightage. NEP pattern to be followed in terms of framework and credit distribution.
